## Prayers for JAGf

- That the Lord would position and prepare JAG and JAGF for the nomination and confirmation of a new Supreme Court Justice if there is a vacancy on the Court this summer.
- The Lord has begun to expand JAGF's activities in its second year as a tax deductible non-profit. Pray that the Lord would give JAGF and its leadership provision, guidance, and favor, so that JAGF would be a good steward of God-given opportunities.

## Supreme Court News

Join us in praying that righteousness and justice would prevail in response to the following news:

- On May 28, Justice Amy Coney Barrett and [her family were swatted at their home in Fairfax County, Virginia](#). Especially in light of the recent assassination attempts on the President, we must pray for the protection of the Justices and that any threats levied and pressure applied would not hinder righteous rulings.
- On May 26, the U.S. District Court in Alabama [barred the use of a 2023 legislatively drawn congressional district map in the upcoming midterm elections](#). The congressional boundaries in several states are pending judicial review after a significant ruling by the Supreme Court on gerrymandering. These upcoming decisions will have a major impact on the 2026 midterm election.

## Case in Focus

Pray for this case pending before the Supreme Court regarding birthright citizenship. Pray that a righteous decision is made.



### Trump v. Barbara

The Supreme Court will soon rule on birthright citizenship. The citizenship clause in the 14<sup>th</sup> Amendment was originally written to ensure that former slaves received full citizenship after the Civil War. As currently applied, the citizenship clause allows children, born in the United States, of illegal immigrants, tourists and temporary residents to receive US citizenship.

### Topics for Prayer

1. That the Supreme Court rightly interprets the citizenship clause of the 14th Amendment as originally intended.
2. That the United States would be protected from those who oppose and dishonor God's intentions and plans for this nation.

1. Pray that the Supreme Court Justices would have the fear of the Lord - the beginning of wisdom.
2. Pray that the Lord delivers the Justices from every snare and plot, that He blesses their security personnel, and preserves their lives.
3. Pray that any Justice that steps down will be replaced by a person who fears the Lord and advances the cause of righteousness in the Nation.
