Prayers for JAGf

- That the Lord would unify the conservative movement and particularly those who believe in judicial renewal. That there would be no discord and that JAGf would stand in one accord with like minded organizations.
- The Lord has begun to expand JAGf's activities in its second year as a tax deductible non-profit. Pray that the Lord would give JAGf and its leadership provision, guidance, and favor, so that JAGf would be a good steward of God-given opportunities.

Supreme Court News

Join us in praying that righteousness and justice would prevail in response to the following news:

- The Supreme Court still has [several critical cases](#) to rule on before the end of the term. Opinions on the remaining cases will be released over the next two to three weeks. Pray that every final decision would align with God's will and His justice.
- On June 2, the Supreme Court [allowed Alabama's preferred congressional map to advance, reversing a lower court order](#). While the temporary order causes the state to move forward with a beneficial map for the Republicans, the Supreme Court will likely need to make a final ruling before the upcoming 2026 election.

The current term of the Supreme Court will end in late June or early July. Out of the remaining cases, JAGf is particularly focused on *Little v. Hecox* and *West Virginia v. B.P.J.* and *Trump v. Barbara*. See our [last two briefings](#) for more on these cases.
